



## Official Contest Rules

**No purchase is necessary to enter or win. A purchase will not increase your chances of winning. All federal, state, and local laws and regulations apply.**

**Eligibility Requirements:** *The contest is open to South Atlantic Bank customers and individuals who are legal residents of the United States and the District of Columbia and who are eighteen years of age or older at the time of entry. South Atlantic Bank employees and/or immediate family (spouse, parents, siblings and children) and household members (whether related or not) of each such employee, are not eligible. Limit one entry per person.*

**Agreement of Official Rules:** *Participation in the contest constitutes full and unconditional agreement to and acceptance of the Official Rules and decisions of South Atlantic Bank, which are final and binding. The odds of being selected depend on the number of entries received. South Atlantic Bank will attempt to notify the potential winner via telephone, e-mail and/or mail on 1/23/23. If the potential winner cannot be contacted within ten (10) days after the date of the first attempt to contact him/her, South Atlantic Bank may select an alternate winner in his/her place at random from the remaining non-winning, eligible entries. The potential winner is responsible for collection of prize.*

**Winner Notification:** *The potential winner will be notified by telephone, e-mail and/or mail. The winner will be required to complete and submit the "South Atlantic Bank (SAB) Winner's Release" form within fifteen (15) days of being notified in order to claim his/her prize.
